## SUMMARY

- The Offer Price has been determined at HK\$1.48 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.48 per Offer Share, the net proceeds from the issue of New Shares under the Share Offer to be received by the Company, after deduction of related underwriting commissions and other listing expenses, is estimated to be approximately HK\$31.6 million.
- A total of 2,556 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS were received, totalling 393,516,000 Public Offer Shares and representing approximately 100.9 times of the total number of 3,900,000 Public Offer Shares initially available under the Hong Kong Public Offer.
- Due to the very significant over-subscription in the Public Offer, the clawback mechanism as described in the paragraph headed “Re-allocation of Offer Shares between the Public Offer and the Placing” under the section headed “Structure and Conditions of the Share Offer” of the Prospectus has been applied and the number of Offer Shares allocated to the Public Offer has been increased from 3,900,000 Offer Shares initially available under the Public Offer to 19,500,000 Offer Shares, representing 50% of the total number of Offer Shares available under the Share Offer.

## **OFFER PRICE AND USE OF NET PROCEEDS FROM THE SHARE OFFER**

The Offer Price has been determined at HK\$1.48 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%). Based on an Offer Price of HK\$1.48 per Offer Share, the Company estimates that it will receive net proceeds from the issue of New Shares under the Share Offer of approximately HK\$31.6 million, after deducting underwriting fees and other related fees and expenses payable by the Company.

### **Use of Proceeds**

The Board intends to apply such net proceeds as follows:

- approximately 86% of the net proceeds, or approximately HK\$27.2 million, for the expansion of our production capacity including construction of new workshops;
- approximately 5% of the net proceeds, or approximately HK\$1.6 million, for the expansion of our sale and distribution network and the promotion of our new products; and
- the remaining approximately 9% of the net proceeds, or approximately HK\$2.8 million for the working capital of our Group.

The Company estimates that the Selling Shareholder will receive net proceeds from the Share Offer of approximately HK\$11.8 million after deducting the underwriting fees and commissions and estimated expenses payable by it in relation to the Share Offer.

A total of 2,556 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS were received, totalling 393,516,000 Public Offer Shares and representing approximately 100.9 times of the total number of 3,900,000 Public Offer Shares initially available under the Public Offer.

Five multiple applications or suspected multiple applications have been identified and rejected. Two applications have been rejected due to dishonoured cheques. No application has been rejected due to invalid applications. No application for more than 3,900,000 Public Offer Shares has been identified.

Due to the very significant over-subscription in the Public Offer, the clawback mechanism as described in the paragraph headed “Re-allocation of Offer Shares between the Public Offer and the Placing” under the section headed “Structure and Conditions of the Share Offer” of the Prospectus has been applied and the number of Offer Shares allocated to the Public Offer has been increased from 3,900,000 Offer Shares initially available under the Public Offer to 19,500,000 Offer Shares, representing 50% of the total number of Offer Shares available under the Share Offer.

The Offer Shares initially offered under the Placing have been moderately oversubscribed.
